4) St Breward Shop Steering Group attended the meeting	DL opened the meeting and referred to his presentation in 1996 at the Annual Parish meeting where he had focused upon the village shop and need for community facilities. He reminded the meeting that the Steering Group had only been in existence for 4 weeks. Dr Kirby Harris (Chairman) and Dawn Barratts (Secretary) of the Village Shop Steering group gave the Parish Council an update with regard to a) an options appraisal for the provision of a new community shop, with costings, b) the analysis of the village questionnaire and c) an anticipated timeline The key points captured included: - an application of support has been made to the Plunkett Foundation for funding - £240 has been secured from Cornwall Councillor D Fairman - St Breward Village Hall Committee have 'in principle' agreed to the siting of a portakabin within their grounds - Councillor Wills advised that Marshgate Village Shop and PO have confirmed that they will be taking on the mobile PO facility. This will visit St Breward on 17 th July in the pub car park, 3-4pm. It will visit on Monday's going forward at this time. All present reminded to use it or loose it St Breward PC were formally asked for a grant of £10000 by Dr Kirby Harris after associated costs had been presented The Parish Councillors asked a variety of questions:

	 a) VS asked if there was a Plan B if the Village Hall did not work out – not at this stage, but the Industrial Units at Chyryn Drive would be worth exploring. b) VS asked about electricity and toilet facilities and if there would be someone responsible for the day to day running of such a facility. Mr KH advised that there would be a management committee or a cooperative society who would need to sort this support. c) VS reminded the Steering group reps that the PC had not precepted for this cost of £10000 d) FC, PvdB, SN & D Wills asked a variety of questions e) The Clerk presented the general and earmarked reserves to the PC so they were reminded of their financial position & commitments previously made. She also reiterated the powers the PC have in this regard. f) DF summarised that over 40 volunteers would be a real help, communities levelling up monies could be considered, g) The Parish Council resolved to support the steering group in principle – proposed by DC, seconded by DP – 6 Councillors were in support and 1 Councillor abstained. h) The Parish council resolved to support a grant of up to £3000 – proposed by DC, seconded by SN, 5 Councillors in support, 1 abstention and 1 not in favour.
